

AGREEMENT on renting a room with private bathroom and refrigerator in a two- or three-bedroom-apartment between

The Tenant full name birth place and date , mother 's name: , permanent residence: ,) hereby agrees

with the Landlord András Szilágyi, (Budapest, .) birth place and date , mother 's name: , permanent residence: ,) as follows

The landlord rents out his previously viewed, 16-20m² room with private bathroom and refrigerator **for one person** in the apartment number 21 the 3rd floor of 1088 Budapest Szentkirályi utca 5.

or

in 28 2nd floor of 1088 Budapest Szentkirályi utca 6.

or

1074 Budapest, Dohány utca 20. 3rd floor apartment number 19

or

for the period of three month

from to for one month.

The rent is for a room in Doh : 215 €

for a room in Szentkirályi utca 245 €/ for and 265 € for two people per month

Common costs 9500 Ft/month

The lease agreement includes the use of internet.

However the lease agreement does not include any cost ,which is in connection with registering the tenant at this residence adress.

The tenant communicates the personal details of those staying in the apartment in writing.

In case of non-payment of rent, utilities or common costs immediate termination of the contract and moving out.

The utilities will be paid on the **on the first day of the month** according to meter, shared with the other room or two other rooms tenant(s).

The tariffs at the moment

1 kWh = 30 HUF

1 m³ gas=108 HUF

1m³ water 600 HUF

The tenant undertakes to send a photograph of the meters **on the 29th** of each month.

Reading of the measures documented upon moving in:

water m³

gas m³

current: kWh

Deposit for overhead cost (utilities) 120€.

Key deposit: 130 € Upon handing over the keys . **Cleaning deposit : 30 €**

Total deposit: **280 €**

In case of non-payment of overheads (utilities) according to the meters or rental fee immediate termination of the contract and moving out within a week.

The apartment has been taken over in a clean condition. If one if I do not experience this condition during the inspection, I will clean the apartment or I am going to ask a cleaning lady. The cost of cleaning will be attached to the rent for the next extension. This is a minimum of 6600 HUF, because that 's the minimum wage for the cleaning lady.

If it takes more than three hours, then accordingly, this cleaning cost increases by 2,200 ft per hour. **Washing machine deposit: 30 € only in such rooms where a washing machine is**

available (Doh 2, Szk28/3, Szk 21/2, Szk 6/2. To be renewed after each repair.

Total deposit of those rooms: 310 €.

The deposit will be returned by the landlord in the same currency upon moving out in case there is no fee (rent, common costs, utilities) must be paid, the keys are returned, the flat is in the same clean condition as upon moving in, no furniture or equipment is missing either damaged.

Deposits, common costs and rent are payable in cash upon moving in.

The tenant undertakes to keep all receipts!

If the owner is prevented from taking the payments over, his daughter of Eszter Budai-Szilágyi. takes over the rent and utilities in her beauty salon at Szentkirályi utca 5.I.8.

If the rent is paid not in € but in HUF, the Hungarian National Bank official exchange rate will be used : <https://www.mnb.hu/web/en>

Also entitled (with the presentation of his power of attorney, Erzsébet Ibolya Székely (1075 Bpest, Kazinczy utca 9. to receive these amounts either in the rented apartment or at 1088 Bpest, Szentkirályi utca 5.fsz. 4/a.

The rent, includes a pillow, duvet, kitchen equipment, microwave, gas cooker, cookery and cutlery.

But **does not include the sheet, towels, bed linen.** This is provided by the landlord on request for **HUF 2000 per person per week.** Replacement of a broken key (broken key to be handed over) 4500 HUF / key. Replacement of a lost key set (lock replacements) HUF 60,000, if the landlord can do it by himself, because it is the cost of the locks.

If it will be done by a locksmith, his job must be paid extra.

The rent includes wifi access. It does not include cleaning during the rental period.

The furnishings of the apartment are included in Annex 1.

Lease termination:

The 30th day before the end of the rental period is the latest notice period. The termination can be done in writing: e.g. e-mail. In other words, the tenant can move out on the 30th day after your termination. Smoking: smoking is prohibited in the rooms of the apartment (bathroom, kitchen, bed room). In case of finding any evidence of this immediate termination of the contract! It is forbidden to change the locks! Immediate termination in case of replacement!

The tenant undertakes to comply with **the house rules** by signing this contract. **Noisy activities are prohibited between 6pm and 6am.**

House party is forbidden even during the day. In case of violation, report and immediate termination of the contract!

The tenant undertakes to keep the **bathroom ' floor always dry by wiping off after every use !!** The tenant shall immediately notify all defects in writing.

The landlord is taking action as soon as possible on the repair/ replacement within a reasonable time. Depending on the nature of the failure, the costs will be shared equally or only paid by one party only.
